I acknowledge, agree, am aware of and assume the many risks associated with being around animals, including but not limited to the risks of being bitten, scratched, jumped upon, knocked over, chased, tripped, infected with a zoonotic disease, or otherwise injured or frightened, as well as the risks of damage to personal property and that Guilford County Animal Services cannot guarantee me or anyone else what type of temperament the animal(s) I am fostering may have, and that I hereby accept responsibility for the animal(s) in my care.

**TO RELEASE FROM ALL DAMAGES AND LEGAL ACTION:**

Hereby releases, waives, discharges damages and legal actions against Guilford County Animal Services, its elected officials, appointed officials, employees, or others working on behalf of Guilford County against any and all claims, demands, suits or loss, including all costs connecting therewith, and for any damages which may be asserted, claimed or recovered against or from Guilford County, its elected and appointed officials, employees, or others working on behalf of Guilford County, by reason of personal injury, including bodily injury or death and/or property damage, including loss of use thereof, which arises out of or related to fostering of an animal from Guilford County Animal Services.
