



Request for Stream Determination

This form is intended for use by anyone requesting a stream determination from the Guilford County Planning & Development Department, Watershed Section for use in the unincorporated limits and contracted townships within Guilford County. Please include all supporting information, as described within each category, with your request. You may submit your request to the Watershed Section via mail, e-mail hlewis@guilfordcountync.gov and scoffey@guilfordcountync.gov, or drop off in person at 400 W. Market St. Greensboro, NC 27401.

Please allow sufficient time for a determination and/or review to be made with consideration for weather conditions and staff availability. There is no fee associated with stream determinations at this time.

All County performed and/or approved determinations are valid for 5 years.

Notes

Property Owner Authorization: Please be aware that all stream determination requests must include the current property owner authorization for the assigned staff to proceed with the determination. This form must be signed by the current property owner to be considered a complete request.

Note to USDA Program Participants: A county approved or preliminary stream determination may not be valid for the provisions stated in the Food Security Act of 1985. If you or your tenant are USDA program participants, or anticipate participation in the USDA programs, you should also request a certified determination from the Natural Resources Conservation Service, prior to starting work.
