This was a regular scheduled monthly meeting of the Continuum of Care (CoC) Board and Executive Committee. The meeting was a virtual event held through the Zoom platform.

# I. Welcome and Introductions – Erin Stratford Owens, Chair

Chair Owens officially opened the meeting with a welcome and greetings to all attendees.

# II. Review and Approve Minutes – 09.09.24 Board/Executive Committee Meeting

The minutes were acknowledged as having been sent and received. Kenyatta Jennings Richardson made a motion to approve the minutes as submitted. The motion was seconded. After question and vote, the motion passed without objection.

## III. Action Items

#### A. Written Standards

Chair Owens noted that there is work to do with the Written Standards to get it to minimum compliance. There will be a called meeting for Board, Executive Committee, and membership together to address the Written Standards on October 21 to meet Emergency Solutions Grant (ESG) and Notice of Funding Opportunity (NOFO) applications deadlines.

# B. Candidates for Membership - D Housing Group

Emily Lewis of the Collaborative Applicant (CA) presented the D Housing Group for membership to the CoC. There was some discussion about the membership process but also that a committee has been developed. Councilwoman Amanda Cook made a motion to approve the recommendation of D Housing to CoC membership. The motion was seconded. After question and vote, the motion was approved with stated concern by Councilwoman Hightower.

## Born to Care, Inc.

Rykiell Turner of the CA presented Born to Care for membership into the CoC. Chair Owens made a motion to put the membership request from Born to Care, Inc. on hold per questions about organization location and service area. The motion was seconded.

Edith Clifford made a motion to approve the recommendations as presented in the document. The motion was seconded. After question and vote, the motion passed without objection. It was asked that the CA and the SPEC Chair spend some time to discuss the process of recommendations. There was recognition of the work by the SPEC Chair and committee for the work done in this process.

# A. Monthly Data Report

A summarized slide presentation was given; there will be format changes to come. The percentage of the unhoused for 2+ years prior to being housed increased. Those agencies recognized for data accuracy and completion in the area of Housing Management Information Systems (HMIS) were: Salvation Army (Greensboro); The Servant Center; West End Ministries. The Michigan Coalition Against

Homelessness (MCAH) is to come in for support training. The data accuracy/completeness score for September was 88.2%.

HMIS Committee Chair Sims noted that they are working through completion and accuracy issues in data reporting and capture. In addition, WellSky and Green River are being looked at in terms of what is the best system. These are considerations for the upcoming Point-in-Time (PIT) Count.

# A. Monthly Data Report

An abbreviated report was provided through the attached Power Point. The By-Name list numbers have decreased as some people have found their own housing or have fallen outside the 45-day period. Those on the By-Name list must engage with CE every 45 days to remain active.
