This was the regular scheduled monthly meeting of the Continuum of Care (CoC) Membership body. The meeting was held virtually via the Zoom platform.

I. Welcome and Introduction - Chair Bernita Sims (Acknowledgement of any guests)

Chair Sims officially opened the meeting at 9:30am. A welcome and greetings were extended, as well as an opportunity for 1st-time participants to identify themselves. No one came forth. An additional ask was made after the Youth Focus presentation.

The Coordinated Entry Committee is facilitating the annual evaluation.

B. Monthly CE Data Report

There are parallel systems with Family Services of the Piedmont (FSP) and Veterans Services. FSP accepts clients outside of Guilford County. The veterans' numbers are staying consistent and 11 veterans were housed. There are right at 500 names on the By-Name list. There is a rise in those in the 30-40 year-old age bracket. The Vulnerability Index-Service Prioritization Decision Assistance (VI-SPDAT) training may take place in July or August, but with NBOFO and ESG cycles approaching, that is under review. Due to staffing challenges, access points may be reduced.

VI. CoC Funding and Resource Development – Cheri Neal

A. HUD Notice of Funding Opportunity (NOFO)

There has been no date received yet for the NOFO process but preparations are underway. Expectations are for the release in the summer.

B. State Emergency Solutions Grant (ESG)

A meeting took place with the state ESG office. The tentative release is around June 11. Multiple trainings have taken place. The monitoring process has begun and there is a new monitoring tool involved. With contracts from HUD, funds have not yet been loaded into LOCCS. HUD has asked agencies to monitor their emails. HUD is now not waiting a month but only 7 days for agreements to be signed.

VII. Municipal Partners and Housing Authorities

A. Greensboro Housing Authority (Crystal Gorham)

There are 38 units occupied within the Emergency Housing Vouchers program. With the Shelter Plus program, 34 units have been occupied. With the Housing Opportunities program, there were 34 units occupied and 3 were picked up.

Due to program changes, reports are due by July 15; expenses should be submitted by early June. For the FY24-25 Request for Proposal (RFP), HUD allocations were slightly increased by \$3.000 for ESG funding.

D. City of High Point (Michelle McNair/Nena Wilson)

1. Shelters Discussion

Megan Scales presented the report for the City of High Point. Reassessments are being made in light of reductions. The 1st Wednesdays are for meetings with shelter providers. West End Ministries is expanding their operating hours.

E. Open Door Ministries (Day Center) – Ryan Ross

Work is still being done with the city and county for a Day Center location. A potential site is being considered. The location (county-owned property) will become public if it is amenable.

F. Guilford County

1. UNCG CHCS Eviction Mediation Program (Data) – Renee Norris/ Stefanie Ledwell

Stefanie Ledwell presented the report for the UNCG program. There were 73 clients engaged. There were 35 eviction mediation cases; 24 Housing Navigations. Of that, 54 were from Greensboro, 3 from High Point, and 12 with no city information. Of those engaged, 81% were females. There were 9 disabled, 10 were homeless, and 4 were unsheltered. The April numbers were Slightly lower than March due to a switch in the court system to eCourts. Chair Sims asked for a graph/chart of activity/trends.

2. Legal Aid of NC – (Janet/Destiney/Charlisa)

Janet Blue reported for Legal Aid of NC. There were 432 people serve through the clinic. In the 1st quarter, there were 669 clients for the Teen Project. There were 97 clients served by Legal Aid, 43 of those new clients. Evictions may be down in the next few months due to the changes to eCourt. Work is being done on changes to data in the system.

The Strategic Plan work was recognized as an important piece of the Gather in Guilford event. A meeting for review is being scheduled for May 22 at 8am. The information is to be shared in the June Board/Executive meeting, and then at the June membership meeting.

Chair Sims spoke on the CoC Board/Executive Committee was presented with information on the CoC Lead and an update/build out with written standards and governance. There was an ask for assistance with the scope of work in moving toward a more comprehensive and streamlined operation. There are discussions taking place.

Kristina Singleton spoke on behalf of the Interactive Resource Center (IRC) having families to come to the shelter. There are no changes; the IRC does not serve families. The IRC served families through the now-dormant Safe Parking program. There were further discussions around the IRC and students in the Guilford County School (GCS) system and resource challenges. The GCS system must spend the allocated American Rescue Plan (ARP) funds by December 2024, at which point organization emergency housing funding ceases. The summer will be spent looking for sponsorships and donation sources.

Recommended CoC Governance Charter Changes

April 2024

The Governance Committee recommends adding two more board spots that may be used for an additional Lived Experience spot, and a second Housing Authority spot.

Current Gov Charter language:

Page 6:

"Guilford CoC Board shall consist of no fewer than thirteen (13) and no more than **twenty-five (25)** voting members."

Revised language:

"Guilford CoC Board shall consist of no fewer than thirteen (13) and no more than **twenty-seven (27)** voting members."

The Governance Committee recommends the language below to be changed to include the immediate past chair on the executive committee no matter their term limit.

Current Gov Charter language:

Page 18:

"Executive Committee: The Executive Committee shall consist of the Chairperson, Chair-Elect, Secretary, **eligible past chair**, Executive Director (or representative) of Collaborative Applicant, Coordinated Entry Committee Chair, Strategic Planning Chair, System Performance and Evaluation Committee Chair and a maximum of five at-large Directors selected by the Board Chair."

Revised language:

"Executive Committee: The Executive Committee shall consist of the Chairperson, Chair-Elect, Secretary, **immediate past chair**, Executive Director (or representative) of Collaborative Applicant, Coordinated Entry Committee Chair, Strategic Planning Chair, System Performance and Evaluation Committee Chair and a maximum of five at-large Directors selected by the Board Chair." Take Action! Comment Today on HUD's Proposed Rule, "Reducing Barriers to HUD-Assisted Housing"



NLIHC urges advocates to <u>comment</u> in support of HUD's recent Notice of Proposed Rulemaking (NPRM), "Reducing Barriers to HUD-Assisted Housing."

The proposed rule would make important changes to HUD's existing screening regulations for applicants with conviction histories or a history of involvement with the criminal-legal system. The proposed changes would reduce unnecessary barriers to HUD-assisted housing that too often prevent people impacted by the criminal-legal system from accessing housing.

The deadline for advocates to submit comments is June 10.

Submit a Comment

Take Action!

Advocates, especially those with lived experience, are encouraged to <u>submit a public comment</u> to help HUD shape the final guidance and support needed

updates. Comments are due by June 10.

Advocates can weigh in with HUD by:

- Submitting a comment. Participating in the public comment period is a great
 way to influence federal policymaking. After the public comment period
 ends, HUD must review and take into consideration all comments before
 publishing a final rule. Your comment can be long or short, written formally
 or informally, based on research or your own experiences and the
 experiences of people you know. Consider answering questions like:
 - What are some of the biggest challenges you have faced trying to find housing?
 - How many apartments did you apply for before finding your current housing?
 - Have you been able to find stable housing, and what has the impact been?
 - o How have these barriers impacted you and your community?
- Using the comment portal from the Vera Institute for Justice (Vera). Vera
 created a comment portal where advocates can submit comments in
 support of the proposed rule. The portal includes a template with a prewritten message that advocates can submit as-is or update with their own
 content. While all positive messages help, comments must be at least 30%
 original content to be fully considered by HUD.

NLIHC will also be circulating a comment for sign-on, open to all state, local, national, and tribal partners. We will continue to update our <u>website</u> with additional resources and information.

Background

HUD released on April 10 a <u>proposal to update existing screening regulations</u> for applicants to HUD-assisted housing with conviction histories or a history of involvement with the criminal-legal system.

Under current policy, public housing authorities (PHAs) and landlords of HUDassisted housing have broad discretion in evaluating current and prospective tenants. As a result, some PHAs and landlords have created additional barriers for people with conviction and arrest records in need of stable housing. These barriers can make it exceedingly difficult – and, for some with conviction histories, impossible – to obtain housing.
