In addition, we will need a <u>certified criminal records check from each county in which you have resided during the past five years.</u> In Guilford County, these may be obtained from the Clerk of Court in the Greensboro or High Point Courthouses.

Our committee meets monthly to review applications. Your application will be weighed on a number of factors, including the results of background/criminal history checks, need, and frequency of visits. Guilford County reserves the right to refuse any application based on the needs of the county. Any said use of identification badges is subject to being recorded by camera and other means.

If your application is approved, you will be sent a notification which will describe the fees and hours we issue badges. Badges will only be valid during normal business hours, and must be renewed annually.
