Feedback gained during Public Meeting #1 provided the team with an initial understanding of assets, challenges, and visions held by County residents and a basis on which team members can tailor future outreach efforts for engaging broader audiences.

During Public Meeting #1, the Planning Team:


- Introduced the Comprehensive Plan process

Demographics of attendees: Attendees were from across the county. There was an opportunity for participants to identify where they live. Not all participants completed the map-pinning; however, those who did were fairly distributed across the Southeast, Southwest and Northwest quadrants, with none pinning the Northeast (See map pinning below). In addition to the map-pinning exercise, demographic cards were distributed, and 11 attendees completed this card.



Summary of Feedback – Public Meeting #1 for the Guilford County Comprehensive Plan Update:

Live Polling:

Following a presentation, an interactive live polling exercise was conducted via Mentimeter allowing for anonymous responses and live results to be presented. Paper copies were made available; however, all participants utilized the online format.

- 1. Which community type best represents where you live?
 - Summary: Most workshop attendees identified as living in suburban subdivisions and rural living or farmstead community types, followed by rural subdivision, mixed-use community, and lastly traditional/historic neighborhoods and multi-family subdivisions. None of the attendees identified as members of a lakefront/waterfront community.

2. Guilford County's greatest assets are...

• Summary: Overall responses regarding County assets can be categorized within themes of education, location, natural and cultural resources, and quality of life. Multiple participants identified the availability of quality higher education through colleges and universities as a key asset of the County. The proximity of contrasting rural and urban qualities and the County's central location within North Carolina were also identified as major assets. Rural open space, farmland, accessible clean drinking, and recreational waters were identified as natural and cultural assets that should be protected. These assets contribute to quality of life within the County along with affordable housing, diversity, safety, and a family friendly atmosphere.

- 3. Guilford County's greatest challenges today are...
 - Summary: Multiple participants identified the need for quality food, job, and school access, concerns about disparities in income, and limited support for aging populations as key challenges the county faces. Development challenges included needs for planned, efficient, and quality growth as part of a cohesive vision. Demands on current infrastructure highlight the need for improved public transportation, public water and sewer. Attendees identified increasing crime and intergovernmental relationships as political challenges. Regarding workforce development, there was support for the local economy and higher paying jobs that can serve as opportunities to encourage youth to remain in the County post-graduation.

Out of this engagement phase, the project team will receive the information needed to begin to craft a vision statement and high-level, overarching goals for the initial draft plan. From there, more detailed and nuanced conversations will occur specific to land use and tools to inform any eventual recommended policies or strategies that will be encompassed by the Plan.
